I/We do hereby accept ownership of this Standard Schnauzer dog which we will keep as a personal pet; and will maintain it in the manner that is the right of this noble animal, as set forth in the placement agreement. I/We will at all times keep the dog away from traffic, properly sheltered and fed, and provide regular veterinarian care. I/We will give love and attention to the dog so that it can be a proud example of the Standard Schnauzer breed.

I/We understand that the said Standard Schnauzer dog has been spayed/neutered prior to being placed in the dog's adopted home.

I/We understand that this dog is being placed for a 4-week (28 day) trial period. If, within this time I/we do not feel that the placement is working to the benefit of the dog or my/our family, I/we will return the dog to the Potomac Valley Standard Schnauzer Club Rescue Service and will receive a refund of the adoption fee. I/We hereby acknowledge that during this trial period, a Potomac Valley Standard Schnauzer Club Rescue Service Representative may visit my/our home. If the Rescue Service Representative is not satisfied with the condition of the Standard Schnauzer, or the conditions in which it is kept, the dog maybe reclaimed by the Rescue Service. In these circumstances no refund of the adoption fee will be made. If I/we cannot, for any reason, keep this Standard Schnauzer, I/we understand that the dog **MUST** be returned to the Rescue Service and **MAY NOT** be transferred to any other party. There will be no refund of the adoption fee after the trial period.

I/We understand that the Potomac Valley Standard Schnauzer Club Rescue Service. has no pecuniary or promotional interest in the placement of any dog, nor does Potomac Valley Standard Schnauzer Club Rescue Service or the Club make any warranty as to the structural soundness, health or temperament of this dog. Every effort has been made by the Rescue Service to test and evaluate the suitability of this dog for placement. I/We agree that neither the Potomac Valley Standard Schnauzer Club Rescue Service nor the Potomac Valley Standard Schnauzer Club.; nor any Club members or others working for and/or associated Potomac Valley Standard Schnauzer Club Rescue Service with the Club will in be any way held liable for any damage or injury done by this dog after it is adopted.
