Foster Home Liability Waiver

As a member in good standing of the Potomac Valley Standard Schnauzer Club (PVSSC) I hereby agree to serve as a "Foster Home" for dogs rescued by the club.

RISKS OF FOSTER CARE: I understand and accept that there is no guarantee that there will not be potential risks associated with accepting a foster dog into my home. Therefore, I hereby assume any and all risks associated with fostering rescue dogs and agree that I will not hold the PVSSC and/or its members liable for any and all damages and/or injuries to myself, other family members, guests, other animals and/or my property resulting from the presence and/or actions of a rescue dog.

EXPENSES: Reasonable and customary expenses (as defined by rescue policy set by the PVSSC Board of Directors (BOD) and rescue chair such as food, flea medication, heartworm medication, routine shots and a general health exam will be covered by the PVSSC rescue fund. Any other expenditure must be approved in advance by the PVSSC Rescue Chair or the PVSSC BOD. Expenses beyond defined reasonable and customary expenses are not guaranteed to be reimbursed without prior approval as described. If an emergency situation exists that requires immediate medical care, the rescue chair and/or a BOD member must be contacted as soon as possible.

FOSTER HOME RESPONSIBILITIES: I will exert my best effort in caring for the rescue dog and will continue to evaluate his/her overall health and temperament in various situations. I understand and agree that I have an ongoing obligation to provide status reports to the rescue chair including but not limited to any actions and/or behaviors exhibited by the rescue dog that may or may not affect his/her eventual placement.

PLACEMENT OF DOG: I understand that the rescue dog is the property of the PVSSC and that I do not have the right to sell or give away said rescue dog without the express consent of the PVSSC Board of Directors and/or rescue chair. I acknowledge and agree that the PVSSC has the absolute right to remove any rescue dog from my care, with or without cause at any time.

This Liability Waiver is the entire agreement between the PVSSC and the foster home. Any disputes that may arise under this Liability Waiver shall be governed by the laws of the state in which the foster home resides.

My signature below, and the signature of all household members age 18 years and older, acknowledges that I (we) have read and fully understand the within Liability Waiver. I (we) agree to the terms and conditions set forth herein fully and completely. No one has offered me anything or coerced me in any manner to sign this Liability Waiver.
