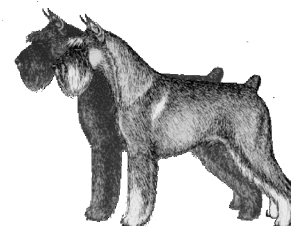

**Parade of Champions & Performance/Obedience Titleholders (non-competitive)**

Ribbons, Trophies and Rosettes will be offered in Obedience, Conformation, Jr. Showmanship, and Parade of Champions and Obedience Titleholders. Professional handlers may enter and handle only dogs they own or co-own. Champions of Record may not compete in regular breed classes.

**On-Site Registration: Obedience 9:00 -10:00 am, Conformation 9:00 am – 1:00 pm**

**Entry fees: Preregistration: \$8.00 for first entry, \$3.00 each additional entry of same dog (preregistration entry form on back of this flyer) \$2 for PARADE only.**

**Day of match: \$10.00 for first entry; \$5.00 each additional entry of same dog**

**Judging Times: Rally – 9:00 a.m followed by Obedience (note early start!)  
Conformation – 1:30 p.m.**

**GRILLED CHICKEN AND PORK BBQ LUNCH WILL BE AVAILABLE AT NOON FOR \$8.00, INCLUDING DRINK**

**Directions: From I-495 (Washington Beltway):** Take Exit 23 North (Rt. 201). (The road changes names from Edmonston Ave. to Old Baltimore Pike.) Go North 4.2 miles to a left at Distribution Drive (look for PVSSC sign and Shepherd's Electrical at corner). Go 0.2 mile (just past 84 Lumber) to right into parking lot. 6826 is half way down on the right, look for signs and banners.

**From I-95** Take exit 29 (Route 212) East towards Beltsville (crossing over I-95). Stay on Ammendale Rd about 1.5 mile, look for large sign "Ammendale Business Center" on left. Take next left onto Virginia Manor Rd., and after 1/2 mile, turn right onto Muirkirk Rd. Go 0.6 m, over Rt 1 and past MARC station, turn right at light onto Old Baltimore Pike. Turn right at Shepherd's Electrical sign onto Distribution Drive and follow directions above.
