### **Participant Information**

No concessions are provided at the event. **No water or snacks will be provided.** This event is outdoors on private property. Rings are accessible to the disabled, however, the portable toilet is not. Plan to work from your vehicle. Participants are required to follow all instructions given in the briefing regarding areas where dogs are allowed. Please follow parking instructions. **BHA COVID Rules are in effect and will be strictly enforced**

### **Description of the trial ring and blind area (all on grass)**

The blind area is outdoors under a canopy tent or may be inside with A/C dependent upon the weather. The ring is indoors on mats

### **Bitch in Season**
